

### LANDLORD FEES SCEHDULE

Please find a list of charges that may apply to you should you wish to market your property with us. We offer a Tenant Find Service, and a full Property Management Service. Although fees are listed below, we invite you to contact us directly for an accurate quote. Please be aware that minimum charges do apply, please enquire for further information.

#### **Tenant Find Service**

If you agree that Baskeys can exclusively market your property we charge 80% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful Tenant Find Service.

If you are marketing your property through another party or medium alongside instructing us on a tenant find basis, we charge 90% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful Tenant Find Service.

A set-up fee of £45.00 (per Tenant) will be charged as part of your Tenant Find Service, which includes ID checks, Right-to-Rent checks, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability. This fee also includes contract negotiation (amending and agreeing terms) and arranging the signing of the tenancy agreement.

A set-up fee of £45.00 (per Guarantor) will be charged where applicable, as part of your Tenant Find Service, which includes ID checks, Right-to-Rent checks, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability. This fee also includes preparing a Deed of Guarantee.





# **Property Management Service**

If you agree that Baskeys can exclusively market your property we charge 75% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful Tenant Find Service.

If you are marketing your property through another party or medium alongside instructing us on tenant find basis we charge 80% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful Tenant Find Service.

We also charge a monthly property management fee of 14% of the rent that we collect on your behalf (16% if the landlord resides outside of the UK).

A set-up fee of £45.00 (per Tenant) will be charged as part of your Tenant Find Service, which includes ID checks, Right-to-Rent checks, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability. This fee also includes contract negotiation (amending and agreeing terms) and arranging the signing of the tenancy agreement.

A set-up fee of £45.00 (per Guarantor) will be charged where applicable, as part of your Tenant Find Service, which includes ID checks, Right-to-Rent checks, financial credit checks, obtaining references from current or previous employers / landlords and any other relevant information to assess affordability. This fee also includes preparing a Deed of Guarantee.

For non-resident landlords, there is a mandatory charge of £75.00 for quarterly returns that must be submitted to HMRC by Baskeys.





## **Additional Services**

During a tenancy, if a tenancy is renewed, then a charge of £160.00 per tenancy will apply, for contact negotiation, amending and updating terms and arranging for the signing of a further tenancy agreement.
