

Landlord – Charge List

Please find a list of charges that may apply to you should you wish to market your property with us. We offer a tenant-find service, a rent collection service and a management service. Although fees are listed below, these are to offer a guide to the charges and we invite you to contact us directly for an accurate quote. Please be aware that minimum charges do apply, please enquire for further information.

Tenant Find

If you agree that baskeys can exclusively market your property we charge 50% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful tenant find service.

If you are marketing your property through another party or medium alongside instructing us on tenant find basis we charge 60% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful tenant find service.

Rent Collection

If the property is exclusively marketed with us, we charge a monthly service charge of 5% of the rent that we collect on your behalf.

If the property is marketed through another party, we charge a monthly service charge of 6% of the rent that we collect on your behalf.

Management

If you agree that baskeys can exclusively market your property we charge 50% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful tenant find service. We also charge a monthly property management fee of 12% of the rent that we collect on your behalf (14% if the landlord resides outside of the UK).

If you are marketing your property through another party or medium alongside instructing us on tenant find basis we charge 60% of the first month's rent (deducted from the 1st month's rent that we collect on your behalf) for a successful tenant find service. We also charge a monthly property management fee of 12% of the rent that we collect on your behalf (14% if the landlord resides outside of the UK).

For non-resident landlords, there is a mandatory charge of £65.00 for quarterly returns that must be submitted to HMRC by baskeys.

Renewal Fee
